

Admissions Arrangements Consultations Response

January 2024

Consultations

In line with our statutory duty as an Admission Authority outlined in the DfE Admissions Code and further to the agreement from Trust Board for three consultations to take place as detailed below, this report provides details of the outcomes for Trustees following the end of consultation.

- No change to admissions arrangements at Beckfoot Allerton, Beckfoot Heaton, Beckfoot Nessfield, Beckfoot Priestthorpe. This consultation is required in line with paragraph 1.45 of the School Admissions Code, which states that admission authorities must consult on their admission arrangements at least once every 7 years, even if there have been no changes during that period. Special schools are not subject to this regulation.
- A reduction to the Pupil Admission Number (PAN) at Beckfoot Oakbank from 300 to 255 or 250.
- An alteration to oversubscription criteria within admissions arrangements for Beckfoot School, Beckfoot Thornton and Beckfoot Upper Heaton to include Beckfoot feeder primaries.

Consultation must last for a minimum of 6 weeks and must take place between 1 October and 31 January in the determination year. In accordance with statutory guidance, these consultations ran from 5 December 2023 to 22 January 2024.

The consultation invited representation from a range of stakeholders including:

- Parents / carers at each school
- Members of the public
- Staff
- All schools in Bradford via the Local Authority
- Bradford Local Authority and North Yorkshire Local Authority

Full details of the consultation and how to access were published on the Beckfoot Trust website, the relevant school websites and Bradford Schools Online. Headteachers updated the school community through newsletters.

Next Steps

As the Admissions Authority, the Trust Board are required to determine the Admission Arrangements for 2025/6 by 28 February 2024.

Respondents who have indicated they would like to be informed of the outcome of consultation will be sent an email with the outcome and decision.

The arrangements will be sent to the Local Authority and published on the school websites by 15 March 2024.

Responses to the 7-year consultation for 2025/26 admission year with no change to admissions arrangements for:

- Beckfoot Allerton
- Beckfoot Heaton
- Beckfoot Nessfield
- Beckfoot Priestthorpe

Trust Response:

The Admissions Arrangements should remain as previously published.

Responses to the consultation for 2025/26 admission year for a reduction to Pupil Admission Number (PAN) at Beckfoot Oakbank with either:

- Reduction of PAN from 300 to 255
- Reduction of PAN from 300 to 250

The reduction is planned in line with the number of places required in Keighley secondary schools and the option chosen will be determined by the responses to the consultation and the Local Authority sufficiency forecasting data which will be updated in January 2024.

There is a forecasted surplus of 46 places by September 2025 in the planning area. The impact on the local area is therefore expected to be a positive one and will allow both Beckfoot Oakbank and other local secondary schools to match the demand for required places.

In addition to supporting effective place-planning in the local area, the reduction will benefit the community at Beckfoot Oakbank. The current school is above average in size, and this can mean that there is less access to large spaces for communal learning, limited space in the canteen and movement around the building can be slow.

Trust Response:

- All 13 in favour commented on the connection between the size of the school and barriers to improvement.
- The 4 not in favour assumed it would lead to a lack of local places. Our initial analysis suggests this is not the case and there may be a surplus.
- The Local Authority are concerned based on initial forecast data that there could be a shortfall. If this is the case, we have agreed with the Local Authority that we will look to provide those places for this year, up to 300 and our published PAN will be officially 250. Further data is due in April.

Responses to the consultation for 2025/26 admission year for alterations to oversubscription criteria at:

- Beckfoot School
- Beckfoot Thornton
- Beckfoot Upper Heaton

The proposed changes to the admission arrangements are:

To create a single Beckfoot Trust local primary feeder school for each of the Trust’s good or outstanding secondaries as detailed in the table below. This will mean that children attending the local primary feeder school will be a 4th priority category to the linked secondary school only (see below). By creating a local feeder school arrangement for our good and outstanding secondaries, children who attend a Beckfoot Primary School can choose and benefit from a Beckfoot Trust education throughout their school career.

Trust Response:

Thornton

- There were no qualitative comments.

- The Local Authority were concerned that if Beckfoot Thornton became more popular with Beckfoot Allerton parents' local children may become displaced. There is no indication that this will happen and there is a projected demographic drop into secondary by September 2026. Thornton has never been over-subscribed. There is a connection between ethnicity and school chosen which does mean this is unable to happen.

Beckfoot School
